## Mare Owner agrees to the following Term and Conditions:

1. All bookings must be made directly with D E & I Gregory, with payment of \$ 1500-00 (Inclusive of G.S.T.). This sum includes a non-refundable handling/booking fee of \$300-00.
2. Copies of the mare's Registration Paper/s must be supplied with the booking.
3. All freight/transportation costs and handling fees must be paid in full to Equine Artificial Breeding Services (EABS) (cleared funds) before despatch of the semen.
4. This contract supplies three breeding doses/straws (three cycles).
5. Any Semen not used will remain the property of the stallion owners and shall not be used to inseminate any other mare unless authorized by the stallion owners. This semen may only be used to attain additional pregnancies if an additional service fee of \$1500-00) (Incl GST) per pregnancy is paid. Any unused semen is to be returned to EABS at the mare owners' expense, or destroyed by the Vet/AI Tech holding the semen. The equitainer must also be returned to EABS,
6. If the mare does not conceive, then the mare owners may exercise their option to substitute another mare for insemination. Additional breeding doses may be purchased at a cost of \$100-00 per dose. The mare owner must notify the stallion owners of a replacement mare prior to insemination.
7. The mare owner must provide the stallion owners with a Veterinarian's Certificate stating a positive pregnancy (45 - 60 days)
8. Should the mare be determined not in foal, abort, or give birth to a dead foal then a Veterinarian's Certificate and written notification providing suitable details must be issued to the stallion owners within 7 days.
9. The stallion owners shall issue a Service Certificate at the end of the program.
10. It is the mare owner's responsibility to liaise with the stallion owners and advise the stallion owners of the mare's status – pregnant or empty.
11. It is the responsibility of the mare owners to register the foal and ensure that the procedure is in accordance with that prescribed by the Riding Pony Stud Book Society Limited. The stallion owners agree to provide the necessary documentation to the Society and/or to the mare owners.
12. If the foal is to be registered as a Riding Pony, the mare owner must undertake the responsibility for the **A.I./ D.N.A. forms**, which must be organised prior to the start of insemination, in accordance with the Regulations of the **Riding Pony Stud Book Society Limited. 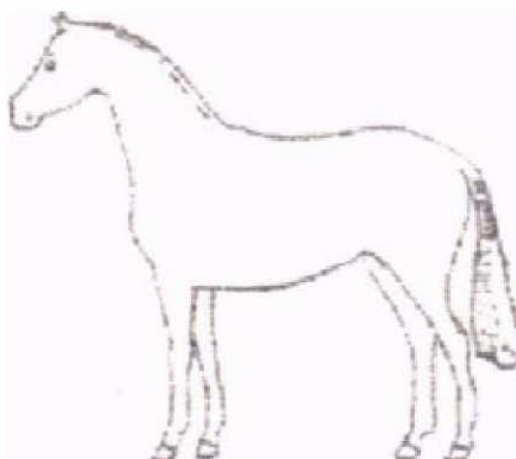
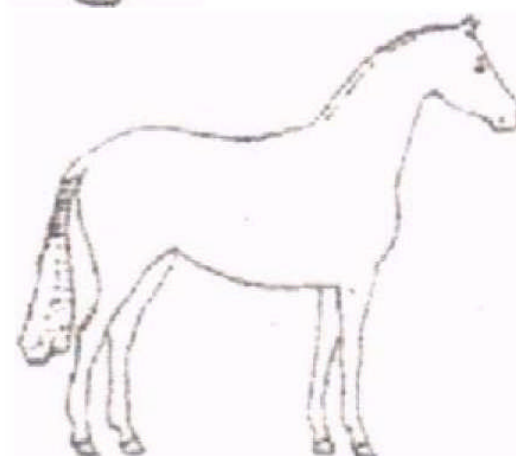
